## **Rector's Ordinance Nr 27/2024**

## of the University of Agriculture in Krakow

of April 22, 2024

regarding the competition for candidates for the Doctoral School of the University of Agriculture in Krakow in the academic year 2024/2025

By Art. 200 sec. 2 of the Act from 20 July 2018 – Law on higher education and science (Journal of Laws from 2023, item 742 as amended) in connection with § 14 sec. 1 of the University Statute from 28 June 2021 (consolidated text from 20 December 2023),

I order the following:

§ 1

I am announcing a competition for candidates for Doctoral School of the University of Agriculture in Kraków in the academic year 2024/2025.

§ 2

- 1. Doctoral dissertations planned for completion should correspond to one of the research topics set out in the Annex to this Order.
- 2. For individual research topics in the Annex, there are also University units to carry out research.

§ 3

- 1. The limit is 22 places in total for candidates applying for admission to the Doctoral School, mentioned in par. § 2 sec.1, in the academic year 2024/2025 is 22 places in total, including:
  - 1.1 17 places for the candidates for education in the basic program of the scientific disciplines and for education in agriculture and horticulture in the Eurohort program:

- 1.1.1 nutrition and food technology 2 places
- 1.1.2 forestry 2 places
- 1.1.3 animal science and fisheries 2 places
- 1.1.4 agriculture and horticulture (included in European Horticulture (Eurohort)) 2 places
- 1.1.5 environmental engineering, mining, and energy 2 places
- 1.1.6 mechanical engineering 2 places
- 1.1.7 civil engineering, geodesy and transport—1 place
- 1.1.8 biological sciences 1 place
- 1.1.9 economics and finance 1 place
- 1.1.10 veterinary –1 place
- 1.1.11 Interdisciplinary (animal science and fisheries; agriculture and horticulture or veterinary and biological sciences) 1 place
- 1.2 5 places for candidates foreigners in the following scientific disciplines:
  - 1.2.1 nutrition and food technology 1 place
  - 1.2.2 forestry 2 places
  - 1.2.3 agriculture and horticulture (included in European Horticulture (Eurohort)) 1 place
  - 1.2.4 animal science and fisheries 1 place.
- Based on the results of the competition Rector may increase the total number of
  places taking into account the strategic directions of research development at the
  University and the quality of the submitted projects.

§ 4

- The conditions and the procedure of the competition proceedings are determined by the Resolution of the Senate nr 18/2024 of 20 March 2024 on the rules of recruitment to the Doctoral School of the University of Agriculture in Krakow.
- 2. Documents required from candidates should be submitted electronically via the IRK system by 16 August 2024.
- In particular candidates should prepare their application in the form of a presentation containing the characteristics of the proposed research project.
- 4. The recruitment procedure will be carried out on 5 September 2024.

The results of the process are public.

The ordinance enters into force on the day of signing.
